# **2016 HIGHLIGHTS**

Stantec acquired Arch|TB in December 2016. Nassal ACM and Arch|TB worked with our partners from the Fort Edmonton Management Company (FEMCo), the Confederacy of Treaty Six First Nations and the Métis Nation of Alberta to develop the programs and space requirements as we go forward with the expansion.
